

## WIN CROWIE'S HELMET SWEEPSTAKES ("Sweepstakes")

### *RULES (the "Rules")*

**NO PURCHASE NECESSARY TO ENTER, PLAY OR CLAIM A PRIZE.**

**A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.**

The Win Crowie's Helmet Sweepstakes is sponsored by Competitor Group, Inc. ("**Sponsor**") and Road ID ("**Sponsors**").

#### **1. ELIGIBILITY:**

The Sweepstakes is available only to those persons, [21] years of age or older (at the time of entry), who are legal residents of the United States or the District of Columbia.
