

RULES

Triathlete 2018 Photo contest

Open to Citizens of the 50 United States, age 18 or older at the time of entry. Void in Puerto Rico and where prohibited by law.

Entrants must have valid email address and it is the entrant's responsibility to update Pocket Outdoor Media of any change in email address.

How to enter: During the contest period, go to Triathlete.com/photocontest to complete and submit the entry form. The contest will be open April 11, 2018 to May 7, 2018.

Entries

By submitting an entry, each entrant agrees to these Official Rules and warrants that his or her entry complies with all requirements set out in the Official Rules.

Submission of entry constitutes permission for Triathlete.com, *Triathlete* magazine and other Pocket Outdoor Media, LLC properties to publish the entered photo image in any medium without compensation to entrant and to use entrant's submitted information for any purpose, including marketing and promotion.

Photo entries must be in digital format. All digital files must be 10 megabytes or smaller, must be in JPEG or JPG format, and must be a minimum of 1,000 pixels wide (if a horizontal image) or 1,000 pixels tall (if a vertical image).

The photograph, in its entirety, must be a single work of original material taken by the Contest entrant. By entering the Contest, entrant represents, acknowledges, and warrants that the submitted photograph is an original work created solely by the entrant, that the photograph does not infringe on the copyrights, trademarks, moral rights, rights of privacy/publicity or intellectual property rights of any person or entity, and that no other party has any right, title, claim, or interest in the photograph.

Up to (5) five photos may be entered by one photographer.

Photos must not be significantly modified. Modifications that are permitted are: resizing, cropping, color correcting (such as adjusting tone, saturation, etc.), removing red-eye, spot editing, sharpening, removing noise, and similar modifications. Composite images are not allowed - This includes any photo that has elements added or removed. Frames, borders, watermarks and copyright notices are not allowed.

Digital files submitted to the contest become the property of Pocket Outdoor Media.

Entries using macro, robotic, script or other forms of automatic entry will be disqualified. Proof of submission does not constitute proof of receipt. The "authorized account holder" is defined

as the natural person to whom the email address is assigned by an internet service provider, online service provider or other organization (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address. Pocket Outdoor Media, LLC shall not be liable for entries and winner notification responses that are delayed, lost, misdirected, mis-delivered, marked postage-due, illegible, mutilated, incorrect or incomplete, and such entries will not be eligible for this Promotion.

Winner Selection
